The external auditors have full and free access to the Council of the District of Barriere and meet when necessary.

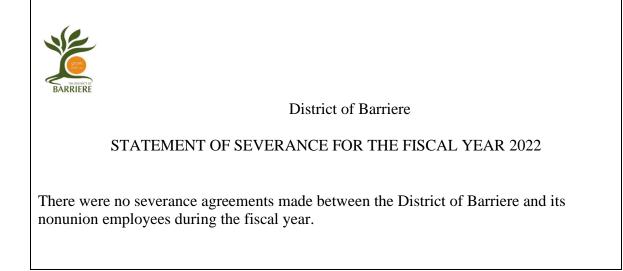
