Bylaw No. 95

A Bylaw respecting the enforcement of Bylaw Notices under the Local Government Bylaw Notice Enforcement Act

The Council for the District of Barriere, in open meeting assembled, enacts the following:

Title

1.1 This Bylaw may be cited as the "Bylaw Notice Enforcement Bylaw No . 95".

Interpretation

2.1 In this Bylaw:

"Act" means the Local Government Bylaw Notice Enforcement Act, S.B.C. 2003, c. 60;

"Adjudication" means the formal decision or judgement given by an administrative authority in resolution of a dispute.

"Agent" means a property use inspector, business licence inspector, building inspector, staff member or other person appointed by the Chief Administrative Officer, acting for the Municipality;

"Bylaw Notice" means a Bylaw Notice under section 4 of the Act and under this Bylaw, in the form of a written notice or ticket, giving notification of a contravention of a bylaw identified in Schedule A;

"Early Payment Amount" means an amount stated in Column 4 of Schedule A that reflects a discount if payment is received by the District within 5 calendar days, or if closed on the 5th day, on the next business day.

"Late Payment Amount" means the amount stated in Column 7 of Schedule A that reflects an amount added to the Penalty if unpaid after 30 calendar days, or if closed on the 30th day, after the next business day.

"Municipality" means the District of Barriere;

"Penalty" means the amount that the recipient of a Bylaw Notice is liable to pay in respect of a contravention of the related bylaw as identified in Column 3 of Schedule A;

"Receive or Receipt" in relation to delivery of a Bylaw Notice, includes the date that, under the Act, a Bylaw Notice is presumed to have been received by the person to whom it is directed;

"Registry" means the District of Barriere Bylaw Notice Adjudication Registry established under section 7.2 of this Bylaw;

"Regulation" means the *Bylaw Notice Enforcement Regulation*, B.C. Reg. 175/2004 under the Act

2.2 A reference to a statute in this bylaw refers to a statute of the Province of British Columbia unless otherwise indicated, and a reference to any statute, Regulation, or bylaw refers to that enactment as it may be amended or replaced from time to time. Except as otherwise indicated in this Bylaw, words and phrases herein are to be construed in accordance with their meanings under the Act, the Regulation, the *Community Charter*, and the *Interpretation Act*, as the context and circumstances require. If any part of this Bylaw is for any reason held to be invalid by a court of competent jurisdiction, the invalid portion is severed and the remainder of this Bylaw continues to be valid.

Bylaw Contraventions

3.1 The bylaw contraventions designated in Schedule A may be dealt with by Bylaw Notice.

Period for Paying or Disputing a Bylaw Notice

- 4.1 A person who receives a Bylaw Notice must, within 30 calendar days of receiving the Bylaw Notice:
 - (a) pay the Penalty to the Municipality in accordance with the Bylaw Notice; or
 - (b) request dispute Adjudication in respect of the allegation on the Bylaw Notice:
 - (i) by completing the Adjudiction notice form on the reverse of the Bylaw Notice, in accordance with instructions on the Bylaw Notice; and
 - (ii) delivering the Adjudiction notice form, either by mail or in person during regular office hours, to the Municipality.

Penalties

- 5.1 The Penalty for a contravention of a bylaw designated in a row of Schedule A is the amount set out in Column 3 of that row.
- 5.2 A person described in section 4.1 may avoid paying the full Penalty amount set out in Column 3 of the Schedule by paying the Early Payment Amount set out in Column 4 within 5 days of receiving the Bylaw Notice.
- 5.3 If, after 30 days of receiving a Bylaw Notice, a person has not:
 - (a) paid the Penalty applicable to the contravention identified on the Bylaw Notice;
 - (b) requested Adjudication in accordance with section 4.1; or
 - (c) paid the Early Payment Amount in accordance with section 5.2,

the person must pay the Late Payment Amount set out in Column 7 of Schedule A.

5.4 In relation to sections 5.2 and 5.3 of this Bylaw, if the last calendar day falls on a day the District of Barriere office is closed for a full day, the last day will be the next calendar day the District of Barriere office is open.

5.5 If a person is reissued a Bylaw Notice under section 25 of the Act, the time limits for responding to a Bylaw Notice under sections 4.1, 5.2 and 5.3 of this Bylaw commence from the time a copy of the Bylaw Notice is delivered to that person.

Payment Period following Adjudicator's Order

6.1 If as a result of adjudication, the adjudicator orders the Penalty to be immediately due and payable to the Municipality, the person must pay that amount within 30 days of the date of the order, or failing to do so, must pay the Late Payment Penalty set out in Column 7 of Schedule A.

Dispute Adjudiction and Registry

- 7.1 A system for Bylaw Notice dispute Adjudication is hereby established to provide for the hearing and determination of disputes in respect of whether:
 - (a) the contravention alleged in a Bylaw Notice occurred as alleged; or
 - (b) the terms and conditions of a compliance agreement were observed or performed.
- 7.2 The District of Barriere Bylaw Dispute Adjudication Registry is hereby established to administer and monitor Bylaw Notices, compliance agreements and requests for adjudication.
- 7.2 The civic address of the Registry is:

7.3 A person who is unsuccessful in a dispute adjudication, whether in relation to a Bylaw Notice or a compliance agreement, must pay, in addition to the applicable Penalty for contravention, a fee of Twenty-five (\$25.00) Dollars to the Municipality.

Screening Officers

- 8.1 The position of Screening Officer is hereby established.
- 8.2 The Chief Administrative Officer is appointed to the position of Screening Officer.
- 8.3 The powers, duties and functions of the Screening Officer include:
 - (a) to review a Bylaw Notice for which a dispute Adjudication is scheduled;
 - (b) where requested by a person who is alleged to have contravened a bylaw, to:
 - i. communicate information respecting the nature of the contravention;
 - ii. identify the provisions of a bylaw contravened;
 - iii. outline the facts forming the basis of an allegation of contravention;
 - iv. confirm the penalty for a contravention;
 - v. provide for the opportunity, if any, to enter into a compliance agreement;
 - vi. refer the matter to Adjudication as necessary; and
 - vii. confirm the fees or fees payable in relation to the Bylaw Notice enforcement process;

- (c) to communicate with any or all of the following persons for the purposes of performing their functions under this Bylaw or the Act:
 - i. the person against whom a contravention is alleged, or their representative;
 - ii. the officer issuing the Bylaw Notice;
 - iii. a complainant or their representative;
 - iv. the staff of the Municipality; and
 - v. an adjudicator, roster organization, or agency of the government;
- (d) where permitted, and in accordance with the Act and Regulation, to prepare and enter into compliance agreements under section 9, including to establish terms and conditions for compliance that the Screening Officer may consider necessary or advisable, including for any compliance agreement discount, time periods for payment of penalties, and compliance with the bylaw that is the subject of a Bylaw Notice;
- (e) to cancel a Bylaw Notice if the Screening Officer determines that the contravention did not occur as alleged, the Bylaw Notice does not comply with the Act, or a ground for cancellation authorized by resolution of Council for the Municipality; and
- (f) on an application under section 5 of the Regulation, to hear the matter, cancel a debt that, due to a circumstance described in those provisions, was not the fault of the debtor, and otherwise to deal with the matter in accordance with the Regulation.

Compliance Agreements

- 9.1 The Screening Officer may enter into a compliance agreement in respect of any bylaw contravention indicated in Columns 5 and 6 of Schedule A.
- 9.2 The maximum duration of a compliance agreement is one year.

Bylaw Enforcement Officers

- 10.1 A person holding any of the following positions may issue a Bylaw Notice under this Bylaw, and otherwise Act to enforce this Bylaw:
 - (a) a member of the Royal Canadian Mounted Police;
 - (b) a bylaw enforcement officer or other agent of the Municipality;
 - (c) a local assistant to the Fire Commissioner under section 6 of the Fire Services Act.

Form of Notice

11.1 A Bylaw Notice or other notice under this Bylaw may be in a form approved by the Chief Administrative Officer of the Municipality.

Other Methods of Enforcement

12.1 Nothing in this Bylaw prevents the Municipality from enforcing a bylaw identified herein by any other proceeding authorized bylaw.
