BYLAW NO. 0013, 2008**

BEING A BYLAW FOR THE LEVYING OF RATES FOR MUNICIPAL,
HOSPITAL DISTRICT AND REGIONAL DISTRICT PURPOSES
FOR THE YEAR 2008
.....

NOW THEREFORE the Council of the District of Barriere, in open meeting assembled, enacts as follows:

1. This Bylaw may be cited as the "District of Barriere Tax Rates Bylaw No. 0013, 2008".
2. The following rates are hereby imposed and levied for the year 2008.
 - a) For general purposes of the municipality on the value of land and improvements taxable for general municipal purposes, rates appearing in Column "A" of Schedule "A" attached to and forming part of this Bylaw.
 - b) For hospital purposes on the value of land and improvements taxable for hospital purposes, rates appearing in Column "B" and "C" of Schedule "A" attached to and forming part of this Bylaw.
 - c) For regional district purposes on the value of land and improvements taxable for hospital purposes, rates appearing in Column "D" of Schedule "A" attached to and forming part of this Bylaw.
3. The minimum amount of taxation upon a parcel of real property shall be One Dollar (\$1.00).

READ A THIRD TIME this 12th day of May , 2008.
