The Fire Chief provided an overview of the written report. She noted that the Playbook is now called the “BC Minimum Standards for Fire Fighters” and 1001 Certification is minimum. Barriere Fire members are currently in the process of achieving this accreditation.

Chief Wohlgemuth noted a correction on the report: 2023 Motor Vehicle incidents should read 0. It was suggested that the CVSE presence is helping in this regard.

The CAO reported that the TNRD has received a grant for Emergency Services and are in the process of hiring a Fire Smart Coordinator position for the region. This new coordinator will help Barriere, along with Area ‘O’, identify various areas.

The CAO provided an overview of the written report and noted that ETSI has been successful in receiving a 10 million dollar grant last week!

- Presented an idea for a Swap/Drop off to the organizers of the Flea Market.

- a. Al Fortin (of Barriere) – Photos show the vast amount of litter recently collected from the Overlander pull-out south of Exlou (in TNRD jurisdiction). *“This is the sort of thing that happens when truckers have nowhere to park and access washroom facilities. Will Council have a discussion on how to solve this issue?”*



It was answered that this sort of thing is a shame as there are a number of washroom opportunities along that stretch of highway and the amount of biohazardous material collected is outrageous. Council will mention this issue at this year's SILGA Convention.
