The Barriere Firefighters Association approached the Recreation Committee asking if it would be interested in assisting with a vendor market during their annual Charity Walk. They did confirm that last year they had a volunteer helper, and the Committee agreed that if this person would like to continue again this year, the Committee has no objection as there are multiple other ongoing projects. Staff will report back to the BFFA.

**7. JAYS CARE FOUNDATION**

Chair Lodge provided an update on the training program that took place the day before which was a success. She, and Kevin Kershaw who will be providing the coaching experience for the program, confirmed the details for the program and this was passed along to Staff to book for the gym. Chair Lodge will create posters and send to Staff to start advertising.
