a. Wastewater Sanitary Sewer Upgrade Options - D. Underwood, TRUE Engineering

Mr. Underwood provided an overview of the written report which has been resubmitted from the June 6, 2022 Council Meeting for discussion. Some clarifications from the previous discussion was made:

- Flow rate
- Possibility of bypassing SAWRC

Isn't it less expensive to have a Class C effluent vs. Class A? There are some options other than Class A, however, there may be limitations on the source of the effluent. Details for clarity regarding surface and non-surface discharge classes need to be outlined in the Preliminary Review.

Current RIB location still recommended should a bypass of SAWRC come to fruition? Answer, yes.

THAT the District proceed with advancing the next step in the design process associated with Option A (maintain the existing discharge quality limits) as outlined in the report; and WHEREAS the next step in the design process comprises preliminary design of treatment process improvements, THAT a preliminary design budget of \$30,000 be allocated.
