Dear Mayor Stamer and Councillors:

Thank you for bringing a delegation to meet with ministry representatives during this year's Union of British Columbia Municipalities (UBCM) Convention. As Deputy Minister, I am writing to acknowledge the topics raised during the meeting with the Minister of Municipal Affairs, which included your community's economic development initiatives and joint Crown Land acquisition efforts with the Simpcw First Nation. It was valuable to hear the discussion on the unique growth pressures Barriere is facing, and the collaborative efforts you are advancing with the Simpcw First Nation.

The ministry understands that it is your intention to apply for the <u>Rural Economic Diversification and Infrastructure Program (REDIP)</u> grant to support housing and economic development in partnership with the Simpcw First Nation. The REDIP is administered by the Ministry of Jobs, Economic Development and Innovation. The ministry also heard your efforts to explore additional grant options. Both the ministry's <a href="Infrastructure Planning Grant Program">Infrastructure Planning Grant Program</a> and the <a href="Asset Management Planning Grant Program">Asset Management Planning Grant Program</a>, administered by UBCM, can assist local governments in strengthening asset management practices and preparing for future capital programs.
