

# **FOUR YEAR FINANCIAL AGREEMENT**

Between

## **THE BARRIERE FIREFIGHTERS' ASSOCIATION & THE DISTRICT OF BARRIERE**

Between

and

### **1. PARTIES**

This Financial Agreement (“Agreement”) is entered into by and between:

The District of Barriere (the “District”), and

The Barriere Firefighters Association (the “Association”).

### **2. PURPOSE**

The purpose of this Agreement is to establish the terms under which the Association will provide financial contributions to the District to support firefighter training activities.

### **3. FINANCIAL CONTRIBUTION**

3.1 The Association agrees to contribute Five Thousand Dollars (\$5,000.00) per year to the District for a period of four (4) years, for a total contribution of Twenty Thousand Dollars (\$20,000.00).

3.2 Payments shall be made in 2026 by March 30<sup>th</sup>, and then annually by February 1<sup>st</sup> as follows:

2026: \$5,000.00

2027: \$5,000.00

2028: \$5,000.00

2029: \$5,000.00

3.3 Recognizing that the Association does the majority of fundraising mid-year, if the Association requires extra time to have the funds readily available, the Association will provide 30 days' notice to the District and inform them of such changes.

#### 4. USE OF FUNDS

4.1 All funds provided under this Agreement shall be used exclusively for firefighter training purposes.

4.2 Council will allocate at least \$5,000 towards Fire Fighter training in their annual budget until 2029.

4.3 The District, shall have full discretion over the allocation and use of the funds, (as decided upon by the Fire Chief), provided such use is directly related to firefighter training and professional development.

#### 5. REPORTING REQUIREMENTS

5.1 The District shall prepare an annual written report detailing how the funds were used during each calendar year.

5.2 The report shall:

Identify the training activities funded; and

Clearly demonstrate how the funds were expended.

5.3 The report shall be completed and provided to the Association no later than December 31st of each year during the term of this Agreement.

#### 6. TERM

This Agreement shall commence on March 10th, 2026, and shall remain in effect until December 31, 2029, unless terminated earlier in accordance with this Agreement.

#### 7. TERMINATION

7.1 The District or Association may terminate this Agreement at any time upon written notice if:

The funds are used for purposes other than firefighter training; or

The Association ceases operations, is dissolved, or otherwise folds.

7.2 Upon termination:

Any unspent funds provided under this Agreement shall be returned to the Association; and

No further payments shall be required.

8. AMENDMENTS

Any amendment or modification to this Agreement must be in writing and signed by both parties.

9. GOVERNING LAW

This Agreement shall be governed by and interpreted in accordance with the laws of the Province of British Columbia.

10. SIGNATURES
