**Location:** Part of Lot 1, DL1482, KDYD, Plan KAP70716 shown cross-hatched on Schedule 'A' to Bylaw No. 199

Bylaw Status: 1st Reading completed February 22, 2021

**Description of Application:** Rezoning to permit the smaller lot size of 2,200 sq.m that has been created by subdivision in the Residential Zone and to permit a reduction to the remaining panhandle lot's road frontage requirement.

**Text Amendment**: "Permitted Uses – Site Specific: The Zoning part of Lot 1, DL1482, KDYD, Plan KAP70716, shown cross-hatched on Schedule 'A' to Bylaw No. 199 – site-specific exception to permit minimum lot size of 2,200 sq m (cross hatched) and;

649 Barriere Lakes Road / remainder (hatched) of Lot 1, DL1482, KDYD, Plan KAP70716, - site-specific exception to permit the frontage requirement for the remaining panhandle lot, be reduced to a minimum of 19 meters."

Mayor Stamer read an opening statement regarding the proceedings of the Public Hearing.

The Corporate Officer provided an overview of the Rezoning Application for the public. A written submission from the applicant was received siting the reasons for the application.

Mayor Stamer called for any submissions from the floor. No submissions were presented.

### 5. PETITIONS AND DELEGATIONS

a. <u>TNRD Invasive Plant Program Proposal</u> – Jamie Vieira, Environmental Services Manager

Mr. Vieira provided a Power Point presentation to Council and reviewed the TNRD's service proposal to member municipalities. Municipalities who subscribe to the service, will receive assistance by way of financial support to qualifying resident applicants and public education from the TNRD to help address the serious impacts that invasive plants are having on communities. It was reported that to date, 5 municipalities have confirmed participation, and 2 municipalities declined.

Some of the invasive plant concerns were noted as follows:

- Hoary Alyssum is toxic to livestock & results in reduced forage and contaminated hay.
- Japanese Knotweed can cause infrastructure damage, affect real estate values and can have environmental impacts.
- Giant Hogweed is toxic to touch, causing sometimes serious burns.

The program provides landowner assistance in the form of 100% of the cost to mediate an identified invasive plant problem up to a maximum \$1500 rebate or up to \$3000 for larger properties, and/or equipment loan-out. There are some terms and conditions that are identified in the publicly posted proposal.

The financial implications were noted as follows:

• Estimate cost to Municipality for 2022 is 2.5% total budget which for Barriere is approximately \$10,000. The budget impact would be for the 2022 budget year, not 2021.

Staff will bring the proposal back to Council for consideration at the next meeting.

## 7. STAFF REPORTS

a. Dixon Creek Subdivision Update - B. Payette, CAO

The CAO provided an overview of the written report. Discussion ensued. Questions and answered presented as follows:

Q: What are the benefits of acquiring that ALR Land? A: *It is an opportunity to increase park space and utilize trail network as part of a much needed municipal controlled asset.* Q: Can we leverage this parkland in trade for other parkland? A: *Likely, yes. Staff will research this feasibility.* 

Q: Is there an insurance premium implication? A: *No, parkland and trail networks are covered under the Municipal Insurance Association.* 

Q: Is selling bulk-water feasible? A: *Normally, the term 'bulk-water' applies to sale of large amounts of water for commercial or construction purposes. In this case, the term* 

'bulk-water' is used more in reference for the delivery mechanism of un-treated water for residential tax-payer use that each property owner will have the responsibility to treat privately, much like property owners that utilize a private well for that use such as on Leonie Creek Rd. The actual feasibility, cost and policy would have to be reviewed and carefully considered.

Q: Do we have the supply? A: At the present while developing DW3 and the unknown surrounding that well's productivity, no.

Chris Delaney, the Developer, provided an overview regarding of the proposed water system for the subdivision. He noted that conditions of use can be made. Mr. Delaney also requested that the proposed ALR donation value be based on an "appraised value" rather than "assessed value" as stated in the report.

The staff recommendations in the report were noted, but it was decided that ongoing discussions during future meetings are needed.

b. FCM Asset Management Grant Submission Resolution - B. Payette, CAO

THAT Council directs staff to apply for a grant opportunity from the Federation of Canadian Municipalities' Municipal Asset Management Program for Roads and Utility Assets planning; and

THAT the District of Barriere commits to conducting the following activities in its proposed project submitted to the Federation of Canadian Municipalities' Municipal Asset Management Program to advance our asset management program:

- 1. The road assessment and pavement management program, and
- 2. Long term investment forecast associated with District assets. This would involve conducting a risk assessment associated with District assets (water and sewer) and then determining the financial contribution (25 Year Investment) associated with asset renewal/replacement within this planning horizon; and

Be it further resolved, THAT the District of Barriere commits \$12,500 toward the costs of this initiative with the funds coming from roads, water & sewer reserves.

c. <u>Barriere River Bridge Repair</u> – C. Matthews, Parks & Roads Manager

The Roads Manager provided an overview of the written report outlining the engineered review of the Barriere River Bridge that found repair work is required as soon as possible. This work has been previously identified in the District's Strategic Plan as necessary.

Moved by Mayor Stamer Seconded by Councillor Armstrong That RFT21-02 Barriere River Bridge Repairs be posted and brought back to Council for confirmation of award.

d. Highway Welcome Signage - C. Matthews, Parks & Roads Manager

Council reviewed the report along with the various design options presented by staff and it was generally agreed that more designs incorporating Barriere's strong ties to the logging industry be incorporated into the design. Staff will bring back additional options at a future meeting.

The CAO provided an overview of the written update.

f. Late Entry Item – Fire Department Capital Purchase

The Fire Chief reported that the Department was notified that for safety compliance, compact compressors are required to be purchased as well as a fill station. The lowest quote found is \$31,320.40 plus taxes from Rocky Mountain Phoenix for this unexpected, but necessary purchase.
