5. **STAFF REPORTS**

a. Yard & Conner Road Paving Update - C. Matthews, Public Works Manager

Mr. Matthews provided an overview of the written report outlining the conditions of Yard and Conner Roads and options moving forward for resurfacing. Commercial Truck parking issues along Yard and Conner Roads were discussed as it was reported that the owner of the PetroCan property is considering utilizing some blockages off of Yard to restrict Commercial truck access through the gas station to reduce wear and tear of his asphalt. Staff will research potential solutions to this issue and report back to Council at a future meeting.

The CAO provided an overview of the written report. It was questioned as to when DW3 will be pushed further in its conditioning process to determine the maximum capacity. It was answered that at the moment, the well is seeing up to 500gal/min without an increase in turbidity. However, determining the maximum flow rate going forward will take some time.
